**Applications to the Tribunal to cancel an
evidence notice**

1. Mae Llywydd Tribiwnlys y Gymraeg ('y Llywydd') yn rhoi'r cyfarwyddyd ymarfer hwn o dan adran 124(1) o Fesur y Gymraeg (Cymru) 2011 ('y Mesur') a Rheol 4 o Reolau Tribiwnlys y Gymraeg 2015 ('y Rheolau'). Cafodd ei gymeradwyo gan Weinidogion Cymru o dan adran 124(2) o'r Mesur.

1. The President of the Welsh Language Tribunal ('the President') makes this practice direction under section 124(1) of the Welsh Language (Wales) Measure 2011 ('the Measure') and Rule 4 of the Welsh Language Tribunal Rules 2015 ('the Rules'). It has been approved by the Welsh Ministers under section 124(2) of the Measure.

Purpose

2. Gwneir y cyfarwyddyd ymarfer hwn er mwyn rhoi canllawiau ynglŷn â sut i wneud cais i'r Tribiwnlys o dan baragraff 9 neu 10 o Atodlen 10 i'r Mesur (cais i ddileu hysbysiad tystiolaeth a roddwyd gan Gomisiynydd y Gymraeg o dan baragraff 5 o'r Atodlen honno).

2. This practice direction is made in order to give guidance as to how to make an application to the Tribunal under paragraph 9 or 10 of Schedule 10 to the Measure (application to cancel an evidence notice given by the Welsh Language Commissioner under paragraph 5 of that Schedule).

3. Gall unrhyw berson sydd wedi derbyn hysbysiad tystiolaeth o dan baragraff 5 o Atodlen 10 i'r Mesur, ac sydd am apelio yn erbyn gofyniadau'r hysbysiad hwnnw, ddefnyddio'r ffurflen Hysbysiad Cais, yn unol â Chyfarwyddyd Ymarfer Rhif 1 y Tribiwnlys. Nid oes angen rhoi tic yn un o'r blychau yn rhan gyntaf adran 3 o'r Hysbysiad, ond dylid cynnwys datganiad o natur y cais, gyda'r rhesymau dros ei wneud, yn y blwch ar gyfe rhoi'r rhesymau hynny (neu mewn dogfen ar wahan os oes angen).

3. Any person who has received an evidence notice under paragraph 5 of Schedule 10 to the Measure, and who wishes to appeal against the requirements of that notice, may use the Notice of Application form, in accordance with the Tribunal's Practice Direction No. 1. There is no need to tick one of the boxes in the first part of section 3 of the Notice, but a statement of the nature of the claim should be included, together with the reasons for making it, in the box for giving those reasons (or in a separate document if necessary).



A person may appeal to the Tribunal against an evidence notice at any time after that notice has been received. The references in the Notice of Application form to a period of 28 days, and to applications to extend that period do not apply, therefore, to applications to


